CHRISTMAS LIGHTING


The Christmas Lighting Committee will be starting to meet soon. If you are interested in this committee contact Paula Wilson.

Volunteers to Go

UGRA hosted its 12th Annual River Clean Up on Saturday, July 25th. A total of 6,315 pounds of garbage was collected by a record 403 participants, working along the river from above Hunt all the way to Center Point. Approximately 920 pounds of this total was separated for recycling; such items included cans, plastic, cardboard, and scrap metal. Along with the expected paper and plastic trash, participants retrieved sheets of plywood, broken porta-potty, three sofas, AC window unit, air pump, car grill, flat screen TV, golf club, lawn chairs, half of a Subway restaurant sign, \$10 bill, lawn mower, fish tank, rubber snake, and 16 tires. The volunteers who recovered these items entered them in to the biggest and most unusual items contest.
